**NOTICE OF HARRY L. PARLETTE IV AND ADELLA F. PARLETTE
REGARDING THEIR JOINDER TO PREVIOUSLY FILED
OBJECTIONS TO TRUSTEE ELECTION and NOTICE THAT
THEIR ATTORNEY, JANET DOUVAS CHAFIN, WILL NOT BE
ATTENDING THE HEARING IN CHICAGO ON JANUARY 13, 2010**

Harry L. Parlette IV and Adella F. Parlette (the "Parlettes") respectfully advise this Court and parties-in-interest that, although they support the objections filed by the bankruptcy trustee, Patrick M. Collins, complaining of the trustee election conducted on November 13, 2009, and filed a joinder in the bankruptcy trustee's objections, the Parlettes and their attorney, Janet Douvas Chafin, will not participate in person at the contested hearing which is scheduled to begin on Wednesday, January 13, 2010.

The Parlettes and their attorney, Janet Douvas Chafin, live in Houston, Texas. Due to the distance and the expense of travel and expense of attorney's fees, the Parlettes and Attorney Chafin will not be attending the hearing in Chicago on January 13, 2010. The Parlettes and Attorney Chafin are not eligible to participate by telephone at this contested hearing in accordance with the Northern District Local Rules.

In light of the magnitude of the Parlettes' investment in certain life insurance policies at issue in this bankruptcy case, as reflected in the claims they have filed in this

bankruptcy case, and the probable substantial loss they have suffered as to their invested funds, the Parlettes cannot prudently allocate additional money to travel and attorneys' fees for them or their attorneys to participate in the hearing in Chicago on January 13, 2010. The Parlettes respectfully request the Court's understanding of their financial situation and their decision 1) not to attend the hearing in Chicago on January 13, 2010, and 2) not to incur attorneys' fees for their attorneys to attend the hearing.
