**THIRD SUPPLEMENTAL AND AMENDED BANKRUPTCY RULE 2019**  
**VERIFIED STATEMENT FOR GROUP OF INVESTOR/CREDITORS**

COMES NOW Johnson, Trent, West & Taylor, L.L.P. of Houston, Texas (“JT”) and SmithAmundsen LLC (“SmithAmundsen”), pursuant to Federal Rule of Bankruptcy Procedure Rule 2019 (“Rule 2019”), supplementing and amending the verified list of claimants represented in the group of investor/creditors (“Group of Investor/Creditors”), as follows.

1. As of 12 PM CDT, Thursday, February 11, 2010, JT has been retained as legal counsel for representation in this bankruptcy proceeding by each of the investor/creditors identified by name and address in Exhibit “A” attached hereto and incorporated herein by reference. This filing supplements Exhibit “A” with additional names, and amends Exhibit “A” to include the amount of claim(s) of each investor/creditor. In all instances, the retention of both firms has been after the filing of bankruptcy petitions initiating these cases.

2. Each of the Group of Investors holds a claim identified by Debtors to be unsecured. None have been contested. No objections have been filed. All claims were acquired more than one year prior to the filing of the petition.

3. Neither JT nor SmithAmundsen hold any claims or interests in any of the Debtors.
